## Your question or feedback

I am writing to offer feedback on Consultation Paper 33-403, "Exploring the appropriatness of introducing a Statutory Best Interest Duty When Advice is Provided to Retail Clients".

The paper asks the question :"Will a fiduciary standard increase the protection of Retail clients?"

In my opinion it will significantly increase the protection of Retail Clients.

I understand that the IIAC questions whether a fiduciary standard would have any practical value. In my opinion it would have great practical value. If it would have little effect, there would surely not be such anguised and lengthy consideration.

The IIAC questions "heaping this on top of other new regulations". In my experience a fiduciary standard would be a Principle, not a New Regulation. I have experienced the reliance on Regultions and Laws in the U.S.A. as a Board member, as opposed to the effect of Principles in the English Common Law, and I heartily recommend the English approach. Boards in the U.S.A. spend their time consulting with Lawyers and Accountants, who in turn spend their time making sure they comply with the letter of the Law, and not necessarily the spirit of the Law. Complying with the spirit of the Law is a much more productive pursuit!

A fiduciary duty is a higher duty than currently exisits. We as Canadians should implement this now.
